After a discussion, Several decisions/resolutions were passed unanimously. They are mentioned below. In the end, Prof. Pankaj Tyagi, Convenor II, proposed a vote of thanks.

### Resolutions Passed-

1. Due to the introduction of new criminal laws and as per the directions of the BCI, changes have been incorporated in the syllabus of LL.B. 3 years, B.A. LL.B, and B.Com. LL.B. courses from the session 2024-25. Copies of the amendments (changes) are annexed herewith. (Annexures 1,2 and 3)
2. A book by Prof. Furqan Ahmed entitled "Muslim Vidhi Ka Vartaman Swaroop" has been added to the list of "Books Recommended" in the subject Family Law – II (Muslim Law) for all the three courses. (Annexures 4, 5 and 6)
3. In B.A. LL.B. and B.Com. LL.B. courses, the Paper Code- BL-9004 namely, Consumer Protection Laws and Competition Act, the Consumer Protection Act 1986 is to be replaced with the Consumer Protection Act 2019. (Annexures 7 and 8)






